## Bridle Springs Home Owners Association Board Meeting 9-3-15

Minutes: The Board APPROVED the minutes from 8-6-15 with a motion by Eric.

The Board ACCEPTED the financial statements for the month of August with a motion by Cecilia.

**Collection:** The Board requested that WCM contact an owner who paid a small amount on their balance at Bridle Springs prior to sending them to collections.

**Neighborhood Watch:** The Board requested that WCM get signs made for the neighborhood watch on Sept 10th.

**Investment Property:** The Board **APPROVED** a motion by Tony to approve two properties to be used as investment property as two owners who were previously approved for use as investment property sold their homes.

**Landscape Specifications Review for contract next year:** The Board reviewed the landscape contract and requested the contract be sent out to bid to three landscape companies.

**Paint Company Quotes for Homes needing paint**: The Board **APPROVED** a motion made by Eric to get three quotes for painting a home in Bridle Springs and to paint the back side of one home in Bridle Springs as a final step of the enforcement process at a cost not to exceed \$1500.

**Appeal of Fine for Noise:** The Board reviewed an appeal from an owner regarding a fine for noise on a property. After reviewing all of the information, the Board **APPROVED** a motion made by Cecilia to keep half of the fines in place at this time.

**Liability/Property Insurance Review**: The Board received a notice that the cost of insurance was increasing 3.9% over last year and **APPROVED** a motion by Kathy to shop around for additional quotes for the same insurance coverage.

## **WCM Updates:**

Play Equipment Update: Ned Stearns will be installing the play equipment later this month when it arrives.

**Sport Court Costs Update:** WCM is continuing to work with Mike from the Sport Court of Oregon to get a price for the basketball court in Bridle Springs.

**Fence Painting Update:** The fence painting should be completed in the next week.

**Easement Update:** The owners of property on Casting have agreed to sign the easement document. WCM will deliver it to the next Board member after the owners sign and notarize the document.

**LED Park Light Update:** M&W Electric have ordered new drivers for the lights in Bridle Springs and will install them later this month.

**Moving Irrigation:** NLS responded to a request by WCM to turn off an irrigation head originating from a common area but presently in the backyard of an owner. NLS ended up not turning off the irrigation head but instead changed a few heads and charged an uncharacteristically high amount. WCM is asking NLS to look into the actual cost of the work.
